RACE AND ETHNICITY DATA

- Two separate questions
- Dedicated write-in response areas for each major group
 - 55 million write-ins in 2010 Census
 - 350 million write-ins in 2020 Census
- Improved data collection and coding for 2020 Census race and Hispanic origin questions

 - Detailed racial and ethnic groups (300): German, Lebanese, Jamaican, Chinese, Native Hawaiian, Mexican, and more!
 - Detailed American Indian and Alaska Native tribes and villages (1,187): The Navajo Nation, the Native Village of Fort Yukon, and more!

DETERMINING THE LEVEL OF DETAIL

- Detailed groups whose national population was less than 50 in the 2010 Census will only receive national- and state-level total population counts and no other data.
- For other groups, we:
 - Infuse a small amount of statistical noise in count.
 - Compare noise-infused count to our population thresholds.
 - Produce tables based on the threshold met for the selected geography.

MORE GROUPS THAN EVER BEFORE

- More write-in response areas
- Improved code list
- Eliminated minimum for population count at the national or state level
- Reduced minimum for population count at county, place, census tract, and AIANNH area levels

RACE AND ETHNICITY CONCEPTS

In addition to providing data for Hispanic origin groups, data will be available for the race *alone* and race *alone or in any combination* populations.

• Race alone

- The minimum number of people who identified as that group.
- Includes people who reported only one response.

• Race alone or in any combination

- The maximum number of people who identified as that group.
- Includes people who reported only one response AND those who reported multiple responses.

ACCURACY

- We are using a stronger system to protect your 2020 Census information against today's cyberthreats while maximizing the utility and relevance of the statistics we publish.
- An algorithm infuses noise small, random additions or subtractions in the statistics.
- We set accuracy targets margins of error (MOE) for how much disclosure avoidance-related uncertainty would be in the published statistics.
- The MOE can be thought of as how close we can expect the noiseinfused counts to be to the enumerated counts approximately 95% of the time.

DATA AVAILABILITY AND SUPPRESSION

- Substantial increase in the number of population counts being published relative to the 2010 Census, where groups had to have a population of least 100 nationally to be included in tabulations.
- Some data suppression to ensure demographic reasonableness:
 - Minimum population threshold for sub-state and AIANNH geographies to prevent the infused noise from disclosure avoidance making it look like populations exist in areas where they do not.
 - Suppressed cases where a noise-infused count fell below zero.
 - Suppressed the *alone* count in areas where the *alone* population count for a group was greater than its noise-infused *alone* or in any combination population count for that area.
- Suppression is specific to a particular geographic area and does not apply to an entire geographic level.



CREATING CUSTOM AGGREGATIONS

- Use caution when creating custom aggregations.
- To create counts for a custom geography, remove or add as few geographies as possible.
- To create custom counts using age data, collapse as few categories as possible.



CUSTOM AGGREGATION EXAMPLE WHERE ADDING IS BETTER

Goal: Create a count of the Samoan alone population for the Pacific West states.

✓ Do:

Add the Samoan alone counts for:

- Alaska
- California
- Hawaii
- Oregon
- Washington

X Don't:

Subtract Samoan alone counts of the 45 other states and Washington, D.C., from the national Samoan alone count



CUSTOM AGGREGATION EXAMPLE WHERE SUBTRACTING IS BETTER

Goal: Create a count of the Mexican population for the 10 Arizona counties that are majority urban.

✓ Do:

Subtract the five counties that aren't urban (Apache, Graham, Greenlee, Navajo, and Santa Cruz) from the Arizona state total Mexican population

X Don't:

Add together the Mexican population for the 10 majority urban counties.



CUSTOM AGGREGATION EXAMPLE – AGE CATEGORIES

Goal: Compare two groups that have different published age categories – one has nine age categories, and one has 23.

✓ Do:

Collapse the table with 23 age categories into nine.

X Don't:

Collapse both tables into four age categories or other custom categories.

MAKING COMPARISONS

- Consider improvements to code list
 - Blog: What You Should Know About the Upcoming Detailed Demographic and Housing Characteristics File A
 - 2020 Census Hispanic Origin and Race Code List
 - Detailed Race and Ethnicity Crosswalk: 2010 to 2020
- Use caution when comparing 2020 Census detailed Asian, NHPI and AIAN race data with 2019 or earlier American Community Survey (ACS) data.
 - Improvements were implemented in the ACS in 2020.
- Use caution when comparing ACS ancestry data and Detailed DHC-A data because of the different methodologies.
 - The detailed groups classified as White, Black or African American, and Some Other Race available in the 2020 Census Detailed DHC-A have historically been tabulated from the <u>ancestry</u> question in the ACS.

- The 2020 Census detailed Hispanic origin data from the ethnicity question are comparable with the 2010 Census and with the ACS regardless of data year.




